# WIN \$1000!

This is a reminder that the deadline to apply for a DRA student scholarships is December 1, 2011. The scholarships will be presented at the February 2012 convention in Monterey.

The Deposition Reporters Association is offering three scholarships in the amount of \$1,000 each to deserving court reporting students, currently enrolled in an approved court reporting program, that are in the 180-and-above speed classes, in qualifier classes, or sitting for the California CSR exam. An applicant sitting for the CSR must continue to be enrolled in school and maintain excellent attendance. The scholarship is intended to be used for school-related and court reporting-related expenses and may be used at the discretion of the recipient.

To be eligible, you must be a student member of DRA.

In addition to the completed application, an official school transcript, and a personal statement, each applicant must provide two (2) letters of recommendation (from teachers, counselors, community or religious leaders, employers, or other nonfamily members) to be sent directly to the Scholarship Committee (see address below and on the application form).

### **Current Legislative Update**

#### **Continuing Ed Bill Update (SB 671)**

The Governor vetoed SB 671, our continuing education bill (co-sponsored with CCRA). The Governor's veto message announced a skepticism of continuing education generally as the reason for the veto. He did not single out our profession as unworthy of CE. We had secured internal support from the Department of Consumer Affairs, and they were surprised about the veto. This is, of course disappointing, but as we noted at our Fall Grab 'N Go, the vetoes can't be predicted. 
